The **CREF/AEPC** invites **Electronic Bids** from eligible Bidders for the **Procurement of Services “Operation of Three Mini Hydro Projects in Jumla and Rukum West District”** under National Competitive Bidding – Single Stage Single Envelope procedures. Bidding is open to all Eligible and Qualified Bidders as mentioned in the Bidding Document.

4. Pre-bid meeting shall be held at the office of **AEPC/RERL, Khumaltar Height, Lalitpur at 11:00 A.M. on 13 January 2025**.
5. Interested Bidders are required to submit the Electronic Bids through e-GP system of PPMO: **www.bolpatra.gov.np/egp** to the office of **AEPC/RERL, Khumaltar Height, Lalitpur** on or before **1:00 P.M. on 26 January 2025**.
6. Submitted Electronic Bids will be opened in the presence of Bidders' representatives who choose to attend at **1:15 P.M. on 26 January 2025** at the office of **AEPC/RERL, Khumaltar Height, Lalitpur, Nepal**.
7. Bids must be valid for a period of 90 days counting from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum **NRs. 75,000.00**, which shall be valid for a minimum of 30 days beyond the bid validity period (i.e., Valid up to minimum **25 May 2025**).
