A. General Provisions

Definitions	<p>(a). “Affiliate(s)” means an individual or an entity that directly or indirectly controls, is controlled by, or is under common control with the Consultant.</p> <p>(b). “Applicable Guidelines” means the policies of the Development Partner (DP) governing the selection and Contract award process, in case of DP funded project. “Applicable Law” means the laws and any other instruments having the force of law in Nepal as they may be issued and in force from time to time.</p> <p>(c). “Borrower [or Recipient or Beneficiary]” means the Government, Government agency or other entity that signs the financing [or loan/credit/grant/project] agreement with the Development Partner.</p> <p>(d). “Client” means the [procuring entity/implementing/ executing agency] that signs the Contract for the Services with the selected Consultant.</p> <p>(e). “Consultant” means a legally-established professional consulting firm or an entity that may provide or provides the Services to the Client under the Contract.</p> <p>(f). “Contract” means a legally binding written agreement signed between the Client and the Consultant and includes all the attached documents listed in its Clause 1 (the General Conditions of Contract (GCC), the Special Conditions of Contract (SCC), and the Appendices).</p> <p>(g). “Data Sheet” means an integral part of the Instructions to Consultants (ITC) Section 2 that is used to reflect specific assignment conditions to supplement, but not to over-write, the provisions of the ITC.</p> <p>(h). “Day” means a calendar day.</p> <p>(i). ”Development Partner (DP)” means the country/institution funding the project as specified in the Data Sheet.</p> <p>(j). “Experts” means, collectively, Key Experts, Non-Key Experts, or any other personnel of the Consultant, Sub-consultant or Joint Venture member(s).</p> <p>(k). “Government” means the government of the Nepal.</p> <p>(l). “Joint Venture (JV)” means an association with or without a legal personality distinct from that of its members, of more than one Consultant where one member has the authority to conduct all business for and on behalf of any and all the members of the JV, and where the members of the JV are jointly and severally liable to the Client for the performance of the Contract.</p> <p>(m). “Key Expert(s)” means an individual professional whose skills, qualifications, knowledge and experience are critical to the performance of the Services under the Contract and whose CV is taken into account in the technical evaluation of the Consultant’s proposal.</p> <p>(n). “ITC” (this Section 2 of the RFP) means the Instructions to Consultants that provides the shortlisted Consultants with all information needed to prepare their Proposals.</p> <p>(o). “LOI” (Section 1 of the RFP) means the Letter of Invitation being sent by the Client to the shortlisted Consultants.</p> <p>(p). “Non-Key Expert(s)” means an individual professional provided by the Consultant or its Sub-consultant and who is assigned to perform the Services or any part thereof under the Contract and</p>

	<p>whose CVs are not evaluated individually.</p> <p>(q). “Proposal” means the Technical Proposal and the Financial Proposal of the Consultant.</p> <p>(r). “RFP” means the Request for Proposals prepared by the Client for the selection of Consultants, based on the SRFP.</p> <p>(s). “SRFP” means the Standard Request for Proposals issued by PPMO, which must be used by the Public Entity as the basis for the preparation of the RFP.</p> <p>(t). “Services” means the work to be performed by the Consultant pursuant to the Contract.</p> <p>(u). “Sub-consultant” means an entity to whom the Consultant intends to subcontract any part of the Services while remaining responsible to the Client during the performance of the Contract.</p> <p>(v). “TORs” (this Section 7 of the RFP) means the Terms of Reference that explain the objectives, scope of work, activities, and tasks to be performed, respective responsibilities of the Client and the Consultant, and expected results and deliverables of the assignment.</p>
<p>2. Introduction</p>	<p>2.1 The Client named in the Data Sheet intends to select a Consultant from those listed in the Letter of Invitation, in accordance with the method of selection specified in the Data Sheet.</p> <p>2.2 The shortlisted Consultants are invited to submit a Technical Proposal and a Financial Proposal, or a Technical Proposal only, as specified in the Data Sheet, for consulting services required for the assignment named in the Data Sheet. The Proposal will be the basis for negotiating and ultimately signing the Contract with the selected Consultant.</p> <p>2.3 The Consultants should familiarize themselves with the local conditions and take them into account in preparing their Proposals, including attending a pre-proposal conference if one is specified in the Data Sheet. Attending any such pre-proposal conference is optional and is at the Consultants’ expense.</p> <p>2.4 The Client will timely provide, at no cost to the Consultants, the inputs, relevant project data, and reports required for the preparation of the Consultant’s Proposal as specified in the Data Sheet.</p>
<p>3. Conflict of Interest</p>	<p>3.1 The Consultant is required to provide professional, objective, and impartial advice, at all times holding the Client’s interests paramount, strictly avoiding conflicts with other assignments or its own corporate interests, and acting without any consideration for future work.</p> <p>The Consultant has an obligation to disclose to the Client any situation of actual or potential conflict that impacts its capacity to serve the best interest of its Client. Failure to disclose such situations may lead to the disqualification of the Consultant or the termination of its Contract and/or blacklisting by the Public Procurement Monitoring Office/DP.</p> <p>Without limitation on the generality of the foregoing, and unless stated otherwise in the Data Sheet, the Consultant shall not be hired under the circumstances set forth below:</p>
<p>a. Conflicting activities</p>	<p>(i) <u>Conflict between consulting activities and procurement of goods, works or non-consulting services</u>: a firm that has been engaged by the Client to provide goods, works, or non-consulting services for a project, or any of its Affiliates, shall be disqualified from providing consulting services resulting from or directly related to those goods, works, or non-consulting services. Conversely, a firm hired to</p>

	provide consulting services for the preparation or implementation of a project, or any of its Affiliates, shall be disqualified from subsequently providing goods or works or non-consulting services resulting from or directly related to the consulting services for such preparation or implementation.
b. Conflicting assignments	(ii) <u>Conflict among consulting assignments</u> : a Consultant (including its Experts and Sub-consultants) or any of its Affiliates shall not be hired for any assignment that, by its nature, may be in conflict with another assignment of the Consultant for the same or for another Client.
c. Conflicting relationships	(iii) <u>Relationship with the Client's staff</u> : a Consultant (including its Experts and Sub-consultants) that has a close business or family relationship with a professional staff of the Client or are directly or indirectly involved in any part of (i) the preparation of the Terms of Reference for the assignment, (ii) the selection process for the Contract, or (iii) the supervision of the Contract, may not be awarded a Contract.
4. Unfair Competitive Advantage	4.1 Fairness and transparency in the selection process require that the Consultants or their Affiliates competing for a specific assignment do not derive a competitive advantage from having provided consulting services related to the assignment in question. To that end, the Client shall indicate in the Data Sheet and make available to all shortlisted Consultants together with this RFP all information that would in that respect give such Consultant any unfair competitive advantage over competing Consultants.
5. Corrupt and Fraudulent Practices	5.1 The GoN/DP requires compliance with its policy in regard to corrupt and fraudulent/prohibited practices as set forth in Section 6. 5.2 In further pursuance of this policy, Consultant shall permit and shall cause its sub-consultants and sub-contractors to permit GoN/DP or its representatives to inspect the accounts, records and other documents relating to the submission of the Proposal and execution of the contract, in case of award, and to have the accounts and records audited by auditors appointed by the GoN/DP. 5.3 Consultants shall be aware of the provisions on fraud and corruption stated in Clause GCC 10.1.
6. Eligibility	6.1 The GoN/DP permits consultants (individuals and firms, including Joint Ventures and their individual members) from the eligible countries as stated in Section 5 to offer consulting services for GoN/DP-financed projects. 6.2 Furthermore, it is the Consultant's responsibility to ensure that its Experts, joint venture members, Sub-consultants, agents (declared or not), sub-contractors, service providers, suppliers and/or their employees meet the eligibility requirements as established by the GoN/DP. Maximum number of partners in JV shall be Specified in Data sheet . 6.3 As an exception to the foregoing Clauses 6.1 and 6.2 above:
a. Sanctions	6.3.1 A firm or an individual sanctioned by the GoN/DP in accordance with the above Clause 5.1 shall be ineligible to be awarded a GoN/DP-financed contract, or to benefit from a GoN/DP-financed contract, financially or otherwise, during such period of time as the GoN/DP shall determine. The list of debarred firms and individuals is available at the electronic address specified in the Data Sheet .

b. Prohibitions	6.3.2 Firms and individuals shall have the nationality of an eligible countries as indicated in Section 5 (Eligible Countries) and: (a) as a matter of law or official regulations, Nepal prohibits commercial relations with that country; or (b) by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations, the Borrower's Country prohibits any import of goods from that country or any payments to any country, person, or entity in that country.
c. Restrictions for public employees	6.3.3 Government officials and civil servants may only be hired under consulting contracts, either as individuals or as members of a team of a consulting firm, if permitted under GoN/DP policy, and their employment would not create a conflict of interest).
B. Preparation of Proposals	
7. General Considerations	7.1 In preparing the Proposal, the Consultant is expected to examine the RFP in detail. Material deficiencies in providing the information requested in the RFP may result in rejection of the Proposal.
8. Cost of Preparation of Proposal	8.1 The Consultant shall bear all costs associated with the preparation and submission of its Proposal, and the Client shall not be responsible or liable for those costs, regardless of the conduct or outcome of the selection process. The Client is not bound to accept any proposal, and reserves the right to annul the selection process at any time prior to Contract award, without thereby incurring any liability to the Consultant.
9. Language	9.1 The Proposal, as well as all correspondence and documents relating to the Proposal exchanged between the Consultant and the Client, shall be written in the English language.
10. Documents Comprising the Proposal	10.1 The Proposal shall comprise the documents and forms listed in the Data Sheet . 10.2 The Consultant shall furnish information on commissions, gratuities and fees, if any, paid or to be paid to agents or any other party relating to this Proposal and, if awarded, Contract execution, as requested in the Financial Proposal submission form (Section 4).
11. Only One Proposal	11.1 The Consultant (including the individual members of any Joint Venture) shall submit only one Proposal, either in its own name or as part of a Joint Venture in another Proposal. If a Consultant, including any Joint Venture member, submits or participates in more than one proposal, all such proposals shall be disqualified and rejected. This does not, however, preclude a Sub-consultant, or the Consultant's staff from participating as Key Experts and Non-Key Experts in more than one Proposal when circumstances justify and if stated in the Data Sheet .
12. Section 7. Terms of Reference for

Conduction of Detailed Feasibility Study for Grid Connection of Micro Hydro Plants of Package 1

1. Introduction

Alternative Energy Promotion Centre (AEPC) is the apex government body under the Ministry of Energy, Water Resources and Irrigation which was established in 1996 with one of the objectives of promotion of Renewable Energy Technologies for enhancement of the socio-economic status of the rural people. The development objective of AEPC is to improve the living standard of rural women and men, increase employment of women and men as well as productivity, reduce dependency on traditional energy and attain sustainable development through integrating the alternative energy with the socioeconomic activities of women and men in rural communities.

2. Rationale for Grid Interconnection

Micro Hydro Projects (MHPs) are primarily built to provide electricity access mainly for lighting and productive end uses applications to rural people of Nepal where national grid is still distance apart from the settlement. Whenever national grid approaches in the community, the things fall apart. For obvious reasons that the national grid can provide unlimited power for their need and less hassle on O&M of the MHP. Thus community abandon the MHP and choose national grid for their electricity need. Ultimately the MHP has left abandoned. To revive the already invested national resources either MHP has to be interconnected with the grid or lease out to local entrepreneurs to run electricity based business like milling, rural carpentry, entertainment center etc.

However there was no conducive policy for grid interconnection of MHP in Nepal before 2014. Nepal Electricity Authority (NEA) board has made decision to interconnect less than 100kW MHP into national grid at 11kV voltage in T-connection scheme in July 2014. Upon removal of barrier, recently four MHPs have been interconnected in the national grid. Despite of unreliable and high outage in the 11kV line, it has been seen that MHP is earning good amount of revenue compared to earlier for community supply. This has led more sustainable way for existing MHP.

In this context, AEPC as nodal agency for promotion of Renewable Energy Technologies in Nepal, it has been decided to provide support to the community for grid interconnection. Since the PPA, Connection Agreement, Operating Procedure etc would be complicated administrative procedure for community, it has to be supported by AEPC. Further the availability of interconnection technology is still not commonly available in Nepalese market, thus AEPC role seems very crucial to realize the grid interconnection of MHP. Furthermore, AEPC intends to conduct detail feasibility study of the following MHPs.

Thus, the purpose of this ToR is to conduct detailed feasibility study (DFS) for these MHPs for grid interconnection.

3. Objectives of the Assignment

To “Prepare detailed feasibility study of national grid interconnection of MHP ”

The specific objective is to:

- Conduct the technical and financial feasibility of the grid interconnection of MHP.
- Collect the documents required for grid interconnection from community as per check list provided by AEPC.

4. Scope of Work

1. Access and understand the approved technical standard for grid interconnection by AEPC and NEA.
2. Conduct the site visit at the MHP plants listed above and provide details of the existing control and protection system in individual plants. Consultant has to mention detailed about existing excitation System (i.e. compounding transformer, Electronic AVR or combination of both).
3. Measure the distance from MHP power house to nearest point of common coupling (PCC) into the grid.
4. Bring out the information about the management of electricity in the vicinity of PCC i.e. whether community managed or NEA managed.
5. Consult with local NEA official / NEA office to obtain the information like, voltage level available at the Point of Common Coupling (PCC), outage rate of the feeder line, total length of feeder line, existing protection system of that feeder line etc.
6. Access the "Checklist" from the AEPC and obtain all the information obtained in the checklist.
7. Based on the observations made, determine the optimal voltage level for interconnection of MHP with grid.
8. Measure the grid electrical parameters near the PCC which should include at least line and phase voltages, frequency, voltage unbalance, outage over a day etc. This should be taken at least for 24hrs in the interval of at least interval of 1hour. Ideal would be for 1 week data.
9. Consultant has to arrange the high accuracy multimeter having feature of measuring voltage, current, frequency, pf, THD etc. AEPC shall share knowledge to conduct above assessment.
10. Carry out the voltage drop analysis with different conductor size, voltage level and power to be transmitted to ensure that the voltage drop at PCC won't be below 0.9pu.
11. Propose the interconnection system which should at least comply following: system reliability and stability, fault levels, protection system, interconnection voltage, study on

voltage flicker and voltage rise, earthing of electricity networks and equipments, reverse power flows, synchronization of generators, islanded operation, surge protection, safety aspect, harmonics etc. These analysis should comply with approved standard for grid interconnection of MHP.

12. The proposed MHP to grid connection concept should include minimum:
 - a. The need for simplicity and flexibility for operation, inspection, safety checks, repair and maintenance.
 - b. The availability of spare parts and other recurring system consumables from numerous suppliers in different countries of origin while maximizing the number of local suppliers; and
 - c. The operating environment under climate and electrical conditions locally.
13. Propose the control (ELC based or governor based), protection system, measurement system suitable for interconnection.
14. Provide the Single Line Diagrams (SLD) and detailed drawings for the purposed interconnection system compatible with approved “Technical Standard for Grid Interconnection” and grid code of NEA.
15. Prepare the bill of quantities of equipments required to implement grid interconnection of these individual MHPs.
16. Prepare the detail technical specifications of the major component proposed.
17. Calculate annual energy generated from individual MHP plant and provide draft monthly energy table to be proposed for PPA with NEA.
18. Perform financial/economical analysis (FIRR/EIRR, NPV etc..) for grid interconnection of MHP to National grid.
19. Perform sensitivity analysis of FIRR with bank loan and subsidy.
20. Clearly bring-out assumptions and risks associated with the interconnection and basis for such assumption and suggest risk mitigation measures.
21. After submission of draft report and before submission of final report, consultant has to make presentation to officials of AEPC and other stakeholders.
22. Consultant has to obtain the documents from community/project owner required for Connection Agreement, PPA, Operating Procedure etc.

5. Inputs from AEPC

There will be following inputs for completing the assignment:

- a. Input from relevant AEPC officers as required.
- b. NEA board decision.
- c. AEPC/NEA approved Grid Interconnection Guideline for MHP
- d. Checklist for DFS study of Grid interconnection of MHP.

6. Human Resources Requirement

6.1 Team Leader cum Electrical Expert or Renewable Energy Expert: The Team Leader must have with 5 years of experience in Electrical/ Electronics Engineering specially in the field of grid connection or Master Degree in the field of Renewable Energy. Additional degree in management, economics, development studies or any other relevant subjects will be an added advantage. The candidate shall have some

experience of working in the field of standards and specifications, individually or in team, of power system related work. The Team Leader will be responsible for coordinating activities pertaining to the activities mentioned in this ToR. Team Leader should possess very good interpersonal, technical and communication skills, as well as proficiency in written and spoken English and Nepali language. The Team Leader should also possess a strong working knowledge of the power sector, quality management system, and rules and regulations of government of Nepal, grid code of NEA etc. Prior proven experience in the field of grid interconnection of MHP system will get higher weightage in the technical evaluation of the proposal.

The consultant shall pay all tariffs, duties, other taxes or charges levied by the GoN at any stage during the execution of the work.

12. Acceptance of Proposal

All rights are reserved with AEPC either to approve or disapprove any proposal without giving any reasons whatsoever. If needed, the consultant will be asked for modifications and presentations of the proposal before approval.

13. Force Majeure:

In case of force majeure, the consultant is entitled to an extension of the completion time. Force majeure is understood to be natural disasters, fires strikes, lockout sabotage, breakdowns and accidents of all kinds, war to like conditions, riot, and civil commotion or due to circumstances beyond the control of consultant. Apart from an extension of the time of completion, force majeure does not entitle the consultant to any compensation for damage or loss suffered.

14. The Right to Audit:

The AEPC's Compliance Unit shall have the right to audit and inspect all books, records and underlying documentation relating or pertaining to contracts or agreements under AEPC, for delivery of goods or services, kept by or under the control of the Contractor including, but not limited to those kept by the Contractor and its employees, agents, assigns, successors and subcontractors.

The Contractor shall maintain such books and records, together with such supporting or underlying documents and materials, for the duration of the contract or agreement and at least to the end of the following Government of Nepal Fiscal Year from the approved date of the completion of the assignment as per contract or agreement with AEPC.

A clause regarding this facility will be included in the contract document.

Section 8. Conditions of Contract and Contract Forms

Foreword

1. Part II includes standard Contract forms for Consulting Services (a Lump-Sum Contract).
2. **Lump-Sum Contract:** This type of contract is used mainly for assignments in which the scope and the duration of the Services and the required output of the Consultant are clearly defined. Payments are linked to outputs (deliverables) such as reports, drawings, bill of quantities, bidding documents, or software programs. Lump-sum contracts are easier to administer because they operate on the principle of a fixed price for a fixed scope, and payments are due on clearly specified outputs and milestones. Nevertheless, quality control of the Consultant's outputs by the Client is paramount.



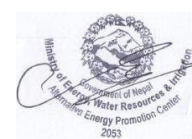
