- Received Proposal (**Technical**) shall be opened in the presence of Proponents' representatives who choose to attend at **above mentioned date and time** at the office of AEPC, Tahachal, Kathmandu, Nepal.
- The method of consultant selection will be Quality and Cost Based Selection (QCBS), **70:30** weightage for Technical and Financial proposals respectively.
- Proposals must be valid for a period of 90 days, counting from the day of Technical Proposal opening. 5 AEPC reserves the right to accept or reject, wholly or partly any or all the proposals without assigning any reason whatsoever.
