Minimum Criteria for Qualification of Solar PV Companies

Following are the minimum criteria that need to be fulfilled for evaluation and verification of the company.

- Criteria is defined for three different categories of qualification i.e. qualification for SHS/SSHS, qualification for ISPS/PVPS and qualification for both SHS/SSHS and ISPS/PVPS.
- Company can apply for any one of the categories.
- Company must fulfill all the criteria to be eligible for evaluation and verification process.
- All the information submitted by the company will be verified in the field and any deviation in information provided and field verification
 report will automatically disqualify the company from further process. In addition the verification will be done for sufficient office
 infrastructure like office space, store, manufacturing/integrating space, battery filling and charging unit, record of inventory in and out of
 the company, detail sales record of the system, quality check record of the products and accounting and book keeping system of the
 company.
- Company must submit all the documents mentioned in the application form.
- Company must submit Copy of Company Registration documents.
- Company must submit Income Tax Registration certificate.
- Company must submit Audit Reports of last two Fiscal Years.
- Company must submit Tax clearance letter of 2069/70.
- Company must submit Brochure of the Company and other promotional materials.
- Company must submit System Users' Manual and Guarantee/Warranty Card.
- Company must submit List of the Names of Company Personnel at head office and their signatures.
- Company must submit Dealership/ Agency Certificates from manufacturers from which the company imports solar PV components, if any.
- Company must submit Company Profile and Information on company operation
- Company must submit Company Business Development Plan
- Company must submit Commitment letter from the company mentioning that they will agree and work as per subsidy policy, subsidy delivery mechanism, system configuration guideline and rules and regulation of AEPC/NRREP and sector code of conduct.
- Deadline for submission of application form is on or before **5 November 2014 (19 Kartik 2071), 2:00 PM**. The application form must reach to AEPC office, Khumaltar on or before above mentioned deadline.
