The **AEPC/RERL** invites **Electronic Bids** from eligible Bidders for the procurement of Goods **“Supply, Delivery, Installation, Testing and Commissioning of Hydro mechanical & Electromechanical Equipment's including Protection system of Barjugad II (40 kW) and Barjugad III (30 kW) Micro Hydro Projects in Bajura District”** under National Competitive Bidding – Single Stage Single Envelope procedures. Bidding is open to all Eligible Bidders as mentioned in the Bidding Document.

4. Pre-bid meeting shall be held at the office of **AEPC/RERL** at **11.00 A.M. on 24 February 2023**.
5. Interested Bidders are required to submit the Electronic Bids through e-GP system of PPMO: [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) to the office of **AEPC/RERL** on or before **1:00 P.M. on 10 March 2023**.
6. Submitted Electronic Bids will be opened in the presence of Bidders' representatives who choose to attend at **1:15 P.M. on 10 March 2023** at the office of **AEPC/RERL, Bakhundole, Lalitpur, Nepal**.
7. Bids must be valid for a period of 90 days counting from the date of bid opening and must be accompanied by scanned copy of the bid security in pdf format, amounting to a minimum **NRs. 70,000.00**, which shall be valid for minimum 30 days beyond the bid validity period (i.e., Valid up to minimum **7 July 2023**).
